December 1st, 2015 Form Changes

Please be advised that most Official Bankruptcy Forms are scheduled to be replaced with substantially revised, reformatted and renumbered versions effective December 1, 2015. The new forms are part of the Advisory Committee's ongoing forms modernization project that began in 2008. The new forms introduce different versions of case opening forms for individual debtors and non-individual debtors. The forms are also easier for debtors to understand and complete, and are designed to work with scheduled enhancements to the federal courts' case opening and electronic case management system. All but six of the existing official forms will be replaced. ECF Filing Tips of The Day...

Filing Multi Part Motions

When filing a multi-part motion, it is important to select an event for each type of relief requested in the motion. By holding down the 'Ctrl' key, the ECF system will allow the filer to select multiple reliefs. For example, if a multi-part Motion for Relief and Abandonment is filed, the filer should select the first part of the motion 'Relief from Stay (fee)' from the available events, and then hold down the 'Ctrl' key while clicking on the second part of the motion 'Abandon (no fee)'. Both selected events will appear in the 'Selected Events ' box on the screen. When selecting multiple events that may require a filing fee, be sure to select only one 'fee' event and the remainder as 'no fee' events. Certificates of Service

Things to remember when preparing the Certificate of Service:

- Specifically state the date of service (it is insufficient to state "on or about");
- Include the name of each party served (it is insufficient to only state "all parties of record have been served");
- Include the address of each party served via U.S. Mail;
- Specifically state the method of service (it is insufficient to only state "electronic service and/or U.S. Mail").

You may include the Certificate of Service in the same PDF as the related document, but if it is filed separately, it should:

- Contain a complete case caption;
- Specifically identify the document(s) served;
- Be linked to the related document(s).

Remember.... Just because a document is electronically filed does not automatically mean that service has been made to the entire matrix. Only attorneys who have filed documents (not including claims) in the case will receive notices of electronic filing (NEFs).

To determine which parties in a case are receiving electronic service, select Utilities>Mailings>Mailing Information for a Case. The screen then displays the parties on the Electronic Mail Notice List and those on the Manual Notice List.
