**GENERAL ORDER ASSIGNING CASES**

Effective January 1, 2018, all cases arising under Title 11 of the United States Code, and any or all proceedings arising under Title 11 or arising in or related to a case under Title 11, shall be assigned as follows:

(1) All cases pending as of the date of this Order or thereafter filed where venue in the Central District of Illinois is based on a debtor's residence, place of business, or other connection to the Illinois counties of Bureau, Fulton, Hancock, Henderson, Henry, Knox, Marshall, Mercer, McDonough, Peoria, Putnam, Rock Island, Stark, Tazewell, Warren, and Woodford are assigned to the Peoria Division. All cases and matters filed in the Peoria Division shall be assigned to the Bankruptcy Judge sitting in Peoria, Illinois.

(2) All cases pending as of the date of this Order or thereafter filed where venue in the Central District of Illinois is based on a debtor's residence, place of business, or other connection to the Illinois counties of Adams, Brown, Cass, Christian, DeWitt, Greene, Logan, Macon, Macoupin, Mason, McLean, Menard, Montgomery, Morgan, Pike, Sangamon, Schuyler, Scott, and Shelby are assigned to the Springfield Division. All cases and matters filed in the Springfield Division shall be assigned to the Bankruptcy Judge sitting in Springfield, Illinois.


(3) All cases pending as of the date of this Order or thereafter filed where venue in the Central District of Illinois is based on a debtor's residence, place of business, or other connection to the Illinois counties of Champaign, Coles, Douglas, Edgar, Ford, Iroquois, Kankakee, Livingston, Moultrie, Piatt, or Vermilion are assigned to the Urbana Division. All cases and other matters pending as of the date of this Order or thereafter filed in the Urbana Division under Chapters 7 and 11 of Title 11 of the United States Code and all adversary proceedings related to Chapter 7 or Chapter 11 cases shall be assigned to the Bankruptcy Judge sitting in Springfield, Illinois. All cases and other matters pending as of the date of this Order or thereafter filed in the

Urbana Division under Chapters 12 and 13 of Title 11 of the United States Code and all adversary proceedings related to Chapter 12 or 13 cases shall be assigned to the Bankruptcy Judge sitting in Peoria, Illinois. Miscellaneous matters and other filings not specifically addressed above shall be assigned to the Chief Bankruptcy Judge.


