

**NOTICE REGARDING CHAPTER 7 AND CHAPTER 13  
TELEPHONIC § 341 MEETINGS OF CREDITORS IN THE  
CENTRAL DISTRICT OF ILLINOIS**

On March 16, 2020, the Office of the United States Trustee issued a notice that all in-person § 341 meetings scheduled through April 10 were to be rescheduled to a later date, unless telephonic or other alternative means of conducting the meeting were arranged which did not require personal appearance by the debtor.
